




Determining Representation:

- Census- population count taken by the Census Bureau
 - > Taken every 10 years
 - > First taken in 1790
 - Helps to adjust/determine number of reps given to each state
 - Some gain and some will lose members in the house- <u>reapportionment</u>

Congressional Districts

- Congressional Districts- each state is divided into one or more congressional district
 - State Legislatures must draw boundariesredistricting
 - All districts must have the same number of constituents
 - California has the most with 53; seven states have just 1



2016 NC CONGRESSIONAL MAP


Gerrymandering

- Gerrymandering- the drawing of oddly shaped districts, designed to increase the voting strength of a particular body
 - Majority party in General Assembly has the power to redraw lines
 - > PEOPLE IN POWER LIKE TO STAY IN POWER
 - Discriminatory practice against minorities.

Types of Gerrymandering

- Packing- concentrating the voting power of the opposing party into one district to reduce their voting power in other districts
- Cracking- diluting the voting power of the opposing party by spreading them out among many districts

Gerrymandering with Skittles

There are 100 citizens in your state. You are a member of the majority party in the state legislature, the Orange Party.
